In this context, how can Europe retool to become a hard power in a world of deterrence and derisking? How can we best defend Ukraine, and stabilize the Middle East? How can we strategically manage interdependence, reduce risks, and forge new relationships with middle powers like those in Asia, Africa, and Latin America? Can we make 2024 the year of Europe's reinvention? Will Europe's fate be decided by Putin, Xi Jinping, or Trump, or can Europeans take their destiny into their own hands in 2024?

Coming together the week where France and the UK go to the polls, and between the EU's top jobs being decided and NATO's Washington summit, this year's ECFR Annual Council Meeting will seek to set Europe's new strategic course in 2024 and beyond.

## Wars and shadow wars: What are Europe's options in the Middle East?

Since Hamas's horrific attacks on 7 October and Israel's devastating response in Gaza, the Middle East has been thrown into deep turmoil. Amid a devastating humanitarian crisis in Gaza, Iran, its allies and Israel are engaged in a low-level regional war, which risks an explosive direct confrontation. The need for a ceasefire and a sustainable political track is acute but remains fundamentally stuck. To the backdrop of wider global challenges and hard questions about the rules-based order, how can European states and the new EU leadership team work with regional partners to address urgent needs on the ground and forge a pathway towards peace and security in Gaza, Israel and the wider region?
